Some rural watersheds have > ¼ of their area drained by road ditches into streams -Sediment & pollutants -Increased flood flows -Decreased infiltration








Act 87 of 2013 (Transportation Bill)

 - \$1M to \$7M for DCNR roads
 - \$4M to **\$28M for municipal and state roads**
 - Of that \$28M, at least \$8M for <u>paved</u> lowvolume roads with <500 ADT




